CONSIGNMENT AGREEMENT

This is an agreement between _____ (the Artist) and the Adornment Gallery. (the gallery) located at 3600 Clipper Mill Rd., Suite 130, Baltimore, MD 21211.

I SCOPE OF AGENCY

The Artist appoints the gallery as his/her agent for the purpose of exhibition and sale of the consigned works listed in the attached schedule of artworks. The gallery shall not permit the artworks to be used for any other purpose, without the written consent of the Artist. This appointment applies only to works consigned and does not make the gallery a general agent for any works not so consigned.

II DELIVERY

The responsibility for artwork and cost of packing, insurance and transportation to and from the venue will be borne by the Artist. The gallery has no responsibility for shipping. If the artist is local, the artist must pick up artwork after period of consignment has expired. After 30 days of expiration of the consignment agreement, all artwork left in gallery becomes property of Adornment Gallery.

III DURATION OF CONSIGNMENT

The Artist and the gallery agree that the initial term of consignment shall be _____ to _____. Thereafter, the consignment shall continue until the Artist requests the return of any or all of the Artworks or the gallery requests that the Artist take back any or all of the Artworks, with which request the other party shall promptly comply.

IV PRICING

The gallery shall sell the Artwork only at the retail price specified on the inventory sheet. The gallery and the Artist agree that the gallery's commission is to be ____% of the retail price of the Artwork.

V ACCOUNTING

The gallery shall furnish a written statement of account for all sales of artwork to the Artist every month. The gallery shall make payment to the Artist within 30 days after the date of sale of any of the Artworks. Payments will be calculated and sent to the artist on or about the 15th of each month. The Artist shall have the right to inspect any records pertaining to sales of their artworks. Such request must be in writing.

For one-of-a-kind artwork with a retail price of \$500 or more, the gallery will furnish upon request, the name, mailing address, and telephone number of the client/collector who purchases the artwork. Artist agrees not to contact the client for the purpose of selling artwork directly to the client and the gallery will be informed or receive a copy of any communication between artist and client that relates to this artwork as long as the contract remains in effect.

VI EXCLUSIVITY

The gallery will have the exclusive/non exclusive right to represent the Artist in the following geographic area _____ for the exhibition and sale of artwork in the following media.

VII TERMINATION OF AGREEMENT

Notwithstanding any other provision of this agreement, this agreement may be terminated at any time by either the gallery or the Artist, by means of 30 days written notification of termination from either party to the other. The gallery relinquishes all liability for artwork abandoned at the gallery 14 days past the termination date.

VIII PROCEDURES OF MODIFICATION

Amendments to this agreement must be signed by both artist and gallery and attached to this agreement. Both parties must initial any deletions made on this form and any additional provisions written onto it. This contract may not be assigned.
